

# PEQUANNOCK RIVER BASIN REGIONAL SEWERAGE AUTHORITY

## GENERAL CONDITIONS PERTAINING TO PRBRSA ENDORSEMENT OF TREATMENT WORKS APPROVALS, NON-RESIDENTIAL CONNECTIONS AND INDUSTRIAL PRETREATMENT PERMITS

The **Applicant** is advised that the following **GENERAL CONDITIONS** apply to all PRBRSA endorsements for Treatment Works Approvals (e.g., sewer extensions), non-residential connections and industrial pretreatment permits.

### GENERAL CONDITIONS

Applicant/Owner/Operator shall abide by the PRBRSA Service Rules ("Rules and Regulations Governing the Discharge of Sewage, Industrial Waste or Other Wastes into the Pequannock River Basin Regional Sewerage Authority and All Sewer Tributary Thereto" dated September 24, 1991) as amended or revised and with the TBSA Service ("Rules & Regulations") of the Two Bridges Sewerage Authority, April 2000 (Revised) and shall file with PRBRSA (3 days prior to construction or initiation of operations) the following documents:

#### 1. CONDITIONS PRECEDENT TO CONSTRUCTION

- a. For Connections to Non-PRBRSA Facilities
  1. Applicant must file with Authority one copy of NJDEP Construction and Operating Permit (for TWA projects)
  2. Applicant must provide 72-hours prior notice before beginning work
- b. For Direct Connections to PRBRSA Facilities
  1. Applicant must file with Authority one copy of NJDEP Construction and Operating Permit (for TWA projects)
  2. Applicant must provide 72-hours prior notice before beginning work
  3. Applicant must obtain a PRBRSA Construction Permit

#### 2. CONDITIONS PRECEDENT TO OPERATION

- a. File NJDEP WQM-005 form "Certification for Approval by Local Agency," which form must be executed (signed and sealed) by a New Jersey licensed professional engineer and must be executed by the municipality which "will own and operate the sewer system."

- b. Applicant must provide 72-hours prior notice prior to initiation of operations
- c. File two sets of record drawings signed and sealed by a New Jersey licensed professional engineer.
- d. File two sets of certified sewer testing results (infiltration or low pressure air testing, visual inspections, etc.).
- e. Prior to discharge into the sewerage system from "any non-residential establishment", the applicant must file and obtain a Non-Residential Connection Approval from the Authority and the Two Bridges Sewerage Authority as prescribed by Article VI of the Service Rules of both agencies.

**NOTE:** For sewer systems which will not be owned or operated by the local municipality, municipal endorsement of the WQM-005 form is not required.

**DISCHARGE OF INDUSTRIAL WASTEWATERS SHALL BE SUBJECT TO THE INDUSTRIAL PRETREATMENT PROGRAM REGULATIONS AND PERMITTING REQUIREMENTS OF STATE & FEDERAL LAW AS ADMINISTERED BY THE TWO BRIDGES SEWERAGE AUTHORITY.**

The Applicant hereby certifies that he will comply with these General Conditions and the TBSA Service Rules including but not limited to **ARTICLE V "PROHIBITIONS AND RESTRICTIONS ON DISCHARGES"** and **ARTICLE VI "DISCHARGE LIMITATIONS & CONDITIONS"** as dated April 2000 (Revised) as appended hereto.
