PRBRSA Annual Report: 2020/2021

February 19, 2020

In the Authority's 33rd year of regional service to the municipalities now is a good time to look back at the accomplishments over the past year as well as the planned achievements on the horizon.

The Authority continues to operate with our mission in mind – the preservation and protection of the Pequannock River Basin while serving our municipalities in the most efficient manner possible. Last year and into the immediate future, PRBRSA has taken and will continue to take the steps necessary to remain true to our mission.

Today, the Authority's member towns — Bloomingdale, Butler and Kinnelon - as well as Riverdale, enjoy the benefits of a regional sewer system, one capable of providing service defined by the towns themselves. Growth and development have been measured yet not restrained, all projects approved by local land use boards have been served. All the while water quality has been measurably improved, the Pequannock River has been restored to provide ecological balance — safe drinking water, trout fishing and recreational opportunities - as tangible by-products.

Antiquated pipelines dedicated to the Authority by the Boroughs of Bloomingdale and Butler have been replaced or rehabilitated. In 2015 through 2017 the Authority completed rehabilitation of the Boonton Avenue Interceptor, lines constructed in the 1930s, to serve the region for decades to come.

Currently we are completing the final stage of that project with the replacement of the lines under and in the vicinity of the NYS&W Railroad in Butler, NJ. That project is underway with a projected completion date of August 2020. The rehabilitation of those lines will complete the PRBRSA's rehabilitation of virtually all the main interceptor sewers acquired from Bloomingdale and Butler in 1987. As an added benefit, the abandoned PRBRSA sewer main in Park Place and Main Street will be repurposed and dedicated to host a water main to serve the residents of the Borough of Butler.

To provide our towns with the upmost transparency in our rates and charges as well as to promote a fair and equitable cost distribution, the PRBRSA Board of Commissioners developed various cost share alternatives. Over recent months the Board considered various methods available and is now implementing an EDU method of billing as a means to avoid significant rate fluctuations produced by flow metering. With the support of the

towns, the service contracts are being developed for approval by the municipalities later this year.

As a longstanding customer municipality, the Borough of Riverdale is formally seeking full membership status as a Participant with two seats on the PRBRSA Board. We look forward to welcoming our new Member municipality by early FY 2021.

To continue to fulfill its mission the Authority is actively pursuing a number of other programs as well:

- Contingency Operating Plan: Succession planning is critical. In 2018 the Authority implemented a plan to continue operations without interruption in the event the current operational approach proves no longer viable. That plan is scheduled for completion by the end of FY 2020.
- Asset Management: The development of a comprehensive plan consistent with recently promulgated state guidelines is being prepared.
- Pipeline Inspection: In conjunction with asset management the Authority has developed a multi-year program to continuously assess the condition of its system. Improvements to the regional system will assure future service reliability and remains the highest priority.
- Park Place Railroad Crossing: To provide necessary hydraulic capacity and assure system integrity, the 1920s vintage line crossing the NYS&W Railroad in Park Place, Butler, a project to replace that segment is actively in progress. As noted above, the project is scheduled for completion this August.

These programs and more will be developed over the next few years to continue PRBRSA's mission of cost efficient, environmentally sound and sustainable service to the municipalities.

OPERATIONAL REPORT

1. SYSTEM OPERATIONS

1.1 Alternative Cost Recovery Methodologies

Mr. Falcon referred to his timeline memorandum of February 11th highlighting the next steps in the process to conclude the Five Party Agreement. That will amend the present service contracts to adopt the EDU method of billing and will simultaneously provide for Riverdale becoming a Member town in accordance with the Sewerage Authorities Law and a direct Participant on the service contract. He mentioned that his office is currently finalizing the draft agreements for review by bond counsel. Mr. Falcon also advised that he would be contacting the attorneys for the 4 municipalities next week to advise them of the forthcoming agreements.

He also advised that the Authority was in receipt of Riverdale's financial analysis. Councilman Desai commented that the report showed a favorable rating for Riverdale. Mr. Falcon agreed, commenting that the Authority would be proceeding with the Five Party Agreement including Riverdale as a Member as previously discussed. Commissioner Lampmann requested an additional timeline for the March meeting outlining the timing for the Borough attorneys' since the ordinances would need to be before the municipalities latest August 2020.

Mr. Falcon confirmed that he would prepare the timeline as well as the ordinances for the towns.

1.2 Flow Report

Ms. Avagnano presented the Flow Reports for the periods ending January 31, 2020 and December 2019.

The following reports were also made available to the Board in their file folders:

Referring to the February 13, 2020 Flow Report, Mr. Kelly noted that the flows through January averaged 1.814 mgd. He particularly noted that Butler's flow is unusually high at 0.904 mgd and for the year-to-date 0.926 mgd or 51.05% of the total flow. He also commented on the differential flow between Meters P-4 and P-2A which remain relatively constant throughout the month whereas the P-4 and P-2A meters exhibited extensive variations over the period.

1.3 TBSA Flow Report (Budget vs. Actual)

Commenting on the actual flows to date versus those budgeted by the Two Bridges Sewerage Authority entering FY 2020, Mr. Kelly reported that the PRBRSA flows are 1.49% higher than TBSA's estimate. Consequently, if that trend continues, the Authority would be assessed an additional user charge for the adjusted flows.

2. TBSA ACTIVITIES

2.1 Status Update

Vice Chairman Voorman addressed the Board on the activities at Two Bridges. He mentioned that as a result of one of the TBSA Participant's exceeding its capacity allocation that PRBRSA should expect a small credit.

The Board also congratulated Commissioner Voorman on his recent appointment as Chairman of TBSA.

3. TWA APPLICATIONS AND CONNECTION PERMITS

3.1 Unauthorized Connection BP Gas Station/Car Wash/Convenience Store Borough of Riverdale

Reporting on the kickoff meeting with Remington & Vernick Engineers on January 6th, Ms. Avagnano indicated that RVE is proceeding with a review of an alternative remediation methodology utilizing spiral-wound PVC in lieu of the cured-in-place liner recommended by R3M. She also advised that a field inspection has been scheduled for Friday, February 21st.

Commissioner Lampmann commented on the video that the Administrator circulated showing the spiral-would PVC technology. In response to Commissioner Howard's comment, Mr. Kelly confirmed that RVE advised that the PVC lining would need to be extended along the entire length from manhole to

manhole, a distance of 445 feet. Consequently, the cost may not be significantly less than the alternative selected by R3M Engineering. He also commented that the engineer will review the ability to install the liner given the PVC liner thickness over the extremely flat slope of the existing 36-inch sewer.

Councilman Desai inquired if the invoices referenced in PRBRSA's January 24, 2020 letter had been forwarded to Riverdale regarding the current costs incurred on the remediation project. Ms. Avagnano responded that the letter issued was only an advisory and that the invoices were not attached. Councilman Desai requested that all invoices paid to date be submitted to Riverdale for transmittal to Riverdale's insurance company. Ms. Avagnano confirmed she would prepare an invoice to Riverdale including the invoices paid to date.

3.2 TWA Application Panera/CVS/Wawa Borough of Butler

Ms. Avagnano reported that the Authority has approved the Non-Residential Connection application for both Wawa and Panera based on information submitted on the grease interceptor design.

3.3 TWA Application Phase 4 Sewer Project Borough of Riverdale

As indicated by his February 10, 2020 review letter, Mr. Kelly recommended approval of the TWA Application filed by the Borough of Riverdale for its Phase 4 sewer project. He explained that the conditions noted by his review have been resolved with the applicant's engineer. He further explained that since the Borough's flows are relatively close to its available reserve capacity that he prepared a Level 1 Capacity Assurance Program calculation. The CAP calculation confirmed that the Borough does have adequate capacity for both the Phase 1 project and the additional flows, 18,900 gpd, for the 63 residential connections proposed to be serviced by the Phase 4 project.

3.4 Northeast Water Quality Management Plan Amendment Linden Street Borough of Riverdale

Commenting on a request from the Borough of Riverdale for an Amendment to the Northeast Water Quality Management Plan to include Lot 10, Block 12 within the sewer service area of the Borough, PRBRSA and TBSA, Ms. Avagnano recommended that the Board approve the Amendment. She commented that Two Bridges also supports the proposed amendment.

4. **BOONTON AVENUE INTERCEPTOR**

4.1 Park Place/NYS&W Railroad Crossing (2017 Project)

Based on the contractor's most recent submittal of a revised construction schedule, Mr. Kelly reported that the upcoming work involves installation of dewatering facilities, relocation of the 30-inch storm drain in Main Street and initiation of the jacking pit installation by the end of March. Commissioner Lampmann commented that no actual work has been initiated as yet with the exception of the test pit work completed over the prior week.

Councilman Desai said he had a question on the methodology used to calculate the FY 2019 flow adjustments. Ms. Avagnano inquired as to which billing he was referring to. Councilman Desai advised that he was specifically questioning the attachment to the December 23, 2019 billing. Mr. Kelly advised that a slight modification to the flow calculations was necessary which was explained by his January 7, 2020 Technical Memorandum. He also advised that Resolution No. R-20-1-3 passed on January 8th outlined the credits to all the towns including minor adjustments to be applied in the 2nd Revised Certifications forthcoming. Ms. Avagnano confirmed that she would forward the information regarding the final FY 2019 billings for Riverdale's information.

Mr. Kelly also noted that, on the unauthorized connection project, that the Authority is attempting to keep costs at a minimum and that we would forward a link regarding a new technology under consideration that may avoid excavation and bypass pumping.

With the questions satisfied and no other members of the public present Chairman Verdonik dispensed with the public participation portion of the meeting.

ADJOURNMENT

At approximately 7:45 pm, Commissioner Lampmann moved to adjourn the meeting. That motion was seconded by Commissioner Howard and approved unanimously on voice vote.
