2.1 ANNUAL STATEMENT

There being no members of the public present, Chairman Verdonik requested that the PRBRSA Annual Report be recorded in the minutes for public viewing as follows:

PRBRSA Annual Report

February 15, 2023

With 36 years of commitment and service to the public and our regional municipalities, PRBRSA continues to operate under our mission to preserve and protect the Pequannock River Basin while serving our members in the most efficient and cost effective means.

Today, the Authority's member towns, Bloomingdale, Butler, Kinnelon and Riverdale, enjoy the benefits of a regional sewer system capable of providing growth and development within our member municipalities while, at the same time, focusing on preservation of the Pequannock River to provide for fishing and recreational opportunities within the communities.

2022 continued with the challenges of the pandemic-related State Health Emergency effecting supplies, project scheduling and exurbanite price increases. Even with added obstacles of the pandemic, the PRBRSA Board successfully completed infrastructure maintenance and inspection projects in order to provide viable information on system operations to the member towns.

Antiquated pipelines have been replaced or rehabilitated. In 2015 through 2020 the Authority completed rehabilitation of the Boonton Avenue Interceptor to serve the region for decades to come as well as a major rehabilitation project completed in 2021 replacing the lines under the NYS&W RR tracks and the surrounding area in Butler, NJ.

In order to allocate charges with utmost accuracy, the Board implemented the 2020 Amended and Restated Service Contract restructuring the billing from a flow-based billing to an EDU method of distributing charges that provides for an evenly balanced and predictable accounting of sewer charges.

The PRBRSA Board continues to have a pro-active outlook and is currently conducting rehabilitation and maintenance programs to ensure continued efficiency within the PRBRSA sewer infrastructure.

We would also like to acknowledge Kinnelon Representative, Commissioner Paul Metcalfe's 15 years of service on the PRBRSA Board.

OPERATIONAL REPORT

1. <u>SYSTEM OPERATIONS</u>

1.1 Flow Report

Chairman Verdonik noted the Flow Report for January 2023 referencing that the flows were within 1% of TBSA M-15 for the month and referred discussions to Steve Donati.

Steve Donati, PE, commented that overall the flows are replicating spring like conditions normally experienced in April and May with high ground water conditions.

He advised the Board that he and Ms. Avagnano met with TBSA on Monday where they discussed the Board's concerns about the differences in the meter readings between P-4 and M-15 over prior months. He explained that TBSA described the procedure for calculating the flow measurements noting that PRBRSA is the only TBSA Member that performs their own metering. He also advised that TBSA collects the data and performs the metering analysis in house whereas meter calibration is performed by an outside company quarterly. Mr. Donati also advised that PRBRSA was present at the M-15 calibration and referenced his memo on the Parshall Flume measuring device utilized by TBSA as well as the calibration process and third-party verification that was used to confirm meter installation for optimum readings. Mr. Donati explained that given the differences in the metering equipment, based on his knowledge, the flume measurement was reading accurately and both meters were in conformity. Commissioner Howard questioned why

TBSA would not average the meters when the readings differed by over 5%. Ms. Avagnano commented that she presented that scenario to TBSA, however, given that M-15 is used as a base for the calculation for distribution of user charges, by averaging with the PRBRSA meter, the other TBSA participant's billings may be effected.

Chairman Verdonik clarified that when the entire TBSA system readings are high, all participants pay a percentage of the overall flow.

1.1.1 I/I Investigations

Chairman Verdonik recommended moving ahead with the PRBRSA proposed I/I program with the assistance of the town's local knowledge. He requested that PRBRSA coordinate with the municipalities for recommendations on metering site locations within the PRBRSA Interceptor by March 6th in order to have the meters installed to capture spring conditions and dry summer periods over the 3 month span.

1.2 TBSA Flow Report (Budget vs. Actual)

See comments above.

1.3 Easements

Diane Alexander, Esq. advised that the temporary access agreement for the Simon property was in final review. She further advised that the permanent right of access would be approached separately as a property appraisal was required.

1.4 Riverdale Interceptor Project

Referencing the proposed Riverdale Interceptor cleaning project, Mr. Donati presented his proposal for engineering services including bid preparation, project engineering and inspection services at the not-to-exceed price of \$52,400 on a time and expense basis.

Chairman Verdonik requested a motion on Resolution No. R-23-2-9.

Treasurer Lampmann moved Resolution No. R-23-2-9 as presented.

WHEREAS, CP Engineering NJ, LLC has completed and submitted a C.271 Political Contribution Disclosure Form and a Business Entity Disclosure Certification, which certifies that the firm has not made any reportable contributions to a political or candidate committee represented by an Authority member in the previous one year, and the contract will prohibit the firm from making any reportable contribution through the term of the contract; and

WHEREAS, the Business Disclosure Entity Certification, the C.271 Political Contribution Disclosure Form, and the Determination of Value has been placed on file with this resolution; and

WHEREAS, the Authority has determined that it is in the interest of the Authority to award a contract for the performance of the services proposed in the attached proposal dated February 10, 2023, submitted by CP Engineering; and

WHEREAS, funds are available for these services from funds appropriated for these purposes in accordance with the duly adopted budget of the Authority, the General Bond Resolution of July 15, 1986 and all supplements thereto, and other implementing resolutions of the Authority.

NOW, THEREFORE, BE IT RESOLVED by the Pequannock River Basin Regional Sewerage Authority in the Counties of Morris and Passaic in the State of New Jersey on this day 15th of February, 2023 as follows:

2. TBSA ACTIVITIES

2.1 Status Update

Related to information received from TBSA on the State Water/Sewer Assistance Program, Diane Alexander, Esq. described the program as it relates to water and sewer customers. She further advised that PRBRSA does not participate in the program since the assistance is awarded through municipalities through public participation/applications for sewer/water billing assistance. As PRBRSA does not bill private users, rather the municipalities, the program does not pertain to PRBRSA. However, she further stated, that PRBRSA is promoting the program in efforts to provide information to our Members. Treasurer Lampmann advised that the Borough of Butler provides brochures and information on the program to their customers with the sewer/water invoices. Ms. Avagnano commented that she would forward more information to the towns on the program for distribution.

Vice Chairman Voorman commented on TBSA's agreement with the State of NJ to provide PFAS samples for testing. He further advised that as a component of the agreement, TBSA would not be penalized based on the samples submitted. Steve Donati explained that PFAS is considered a forever chemical that is currently under regulations in the water industry which is now expanding to include regulations for wastewater facilities.

Ms. Alexander commented that AEA is currently working with legislature to shield Authorities from potential liabilities under volunteer sampling including source reduction given the high costs to treatment facilities.

Discussions continued on the matter regarding effluent levels for wastewater and internal testing capabilities as well as remediation efforts for high levels.
