January 17, 2018

Minutes of the regular meeting of the **Pequannock River Basin Regional Sewerage Authority** held on January 17, 2018 in the Conference Room at the Butler Municipal Building, One Ace Road, Butler, New Jersey. Chairman Voorman called the meeting to order at approximately 7:30 p.m.

OPERATIONAL REPORT

1. System Operations

1.1 Flow Report

Referencing the December 15, 2017 draft Flow Report for the period ending November 30, 2017, Mr. Kelly advised that the total system flows remain extremely low at 1.395 mgd. He noted that the Authority's Meter P-4 readings remain close to TBSA's Meter M-15 reading of 1.426 mgd, a 2.2% difference.

1.2 TBSA Flow Report (Actual vs. Budgeted Flow)

As indicated by his January 10, 2018 memorandum, Mr. Kelly reported that the Authority's flows remain substantially below the contractual minimum with Two Bridges at 1.85 mgd. If this trend were to continue the Authority would see a 5.95% increase in the Two Bridges User Charge billings at year end.

1.3 PRBRSA Interceptor Inspection: Contract PRB-17-1

Mott MacDonald's January 16, 2018 status report advises that National Water Main Cleaning Company has completed all of the sewer line cleaning and CCTV-inspection. Additionally, the contractor has inspected a total of 37 manholes with 8 manhole inspections remaining. According to National Water Main's current schedule the work will be completed by the January 22, 2018 contract completion date.

2. TBSA Activities

2.1 Status Update

Chairman Voorman and Vice Chairman Verdonik reported on matters at Two Bridges as they affect Pequannock River Basin. Broadly they said that Two Bridges is pressing its contractor on the wastewater treatment plant improvements to expedite the remaining work which remains substantially behind schedule.

3. TWA Applications and Connection Permits

3.1 Non-Residential Connection Curly's Ice Cream Borough of Riverdale

Mr. Kelly reported that the owner of Curly's Ice Cream has requested information in order to file an application for connection to the Authority's system.

3.2 Unauthorized Connection BP Gas Station/Car Wash/Convenience Store Borough of Riverdale

Based on the CCTV-inspection videos, an unauthorized connection has been made to the Authority's interceptor sewer connecting what is generally known as the BP property consisting of three separate uses - a convenience store, gas station and car wash. As previously reported, an unauthorized connection to the Authority's system would normally be a significant matter but in this case the consequences are elevated due to the potential for adverse affects on the integrity of the pipe. Accordingly, Mr. Kelly said that the matter will be addressed with the Borough and with the property owner.

3.3 Non-Residential Connection Quick Chek 1441 Route 23 South Borough of Butler

For the record Mr. Kelly reported that the Non-Residential Connection application for this property has been approved.

3.4 TWA Application Mathews Avenue/Stonehouse Road Borough of Riverdale

Concerning the status of the Mathews Avenue/Stonehouse Road TWA application, Mr. Kelly said that he contacted the Borough of Riverdale which forwarded the NJDEP TWA approval permit as the towns received that day. Mr. Kelly said that NJDEP issued the permit on January 10, 2018.

4. Boonton Avenue Interceptor Project

4.1 NYS&W Railroad Crossing (2017 Project)

Mr. Kelly reported that Butler Borough Administrator Lampmann and he met with Green Acres officials on January 5th. A summary of the meeting was distributed to the Board on January 10th. He characterized the meeting as productive. He said that Green Acres foresees little issue in ultimately securing approval yet the NJDEP regulatory requirements for such approvals must be met including, for example, filing a combined pre and final application, compensating the Borough of Butler for the diversion (\$2,500), convening a public hearing and submitting an environmental assessment along with an engineering alternatives evaluation among other requirements. He indicated that the application must first be approved by the Commissioner of NJDEP and ultimately by the State House Commission.

In order to move ahead Mr. Kelly said three Board actions are needed to expedite matters. They include approving a contract with DMC Associates for additional utility survey of utility information and associated mapping. Additionally he said DMC will need to prepare a plat and metes and bounds description for the temporary easement as well as the permanent easement. That will be required not only for the property transfer rights but also for Green Acres purposes as well. Mr. Kelly, by letter dated January 12th, recommended award of the DMC contract in the amount of \$1,150.

Next, Mr. Kelly said that the Authority is now in position to move forward with the engineering design and related work including LSRP services as may be required, permits and applications and finally bid phase services. He noted that the construction phase services will not be authorized at this time, they will be subject to further negotiation with the engineer. By letter of January 12th he recommended award of the engineering contract to Mott MacDonald for the prices quoted in MM's January 11, 2018 proposal in the amount of \$74,000.

Additionally Mr. Kelly said authorization to conduct two extra soil boring sampling and testing protocols is needed. He explained that the additional work should enable certifying that the spoil materials to be disposed during construction are "clean" under NJDEP regulations. He said while there are no assurances that the additional testing will satisfy the disposal facility requirements Mott MacDonald believes that that should be the case. As indicated by his January 13, 2018, letter Mr. Kelly recommended additional authorization to Mott McDonald in the amount of \$3,500.

1.2 **Audit: FY 2017**

Mr. Kelly reported that the audit has been circulated to the Board in draft form over letter dated January 12, 2018 and asked if any of the Board Members have comments to let him know or to speak directly with the auditor. He advised that the audit provides an unqualified opinion again this year.

1.3 Arbitrage Reserve Contribution: FY 2018

As indicated by Jamie Avagnano's December 11, 2017 memorandum, since the amount remaining in reserve exceeds the amount of contribution calculated for FY 2018 (per Schedule 5) there will be no need to make an additional contribution to that reserve for the current budget year. Mr. Kelly said that the present balance of \$13,072.67 will be increased for the FY 2017 budgeted contribution of \$30,000 bringing the total reserve to \$43,072.67.

1.4 Kelly Engineering Agreement

On presenting Kelly Engineering's request for increases to the compensation paid under the firm's current engineering agreement, Mr. Kelly responded to questions and comments from the Board.

The Board questioned the need for increases of the magnitude requested notwithstanding the fact that the firm has not had any fee increases for 11 years, since February 2007. While there may have been some level of agreement with the request for the hourly rate increases there was little support for the request for the lump sum fee component. The Board requested that Mr. Kelly submit additional documentation in support of the firm's request for increases to the firm's fee compensation.

1. Contingency Operating Plan

1.1 Authority Administrator Position

Mr. Falcon distributed a copy of a January 16, 2018 legal memorandum explaining the changes in the Shared Services Agreement as well as the Employment Agreement concerning the new position of Authority Administrator. He explained that the revisions to the Shared Services Agreement previously approved by the Authority are the result of comments received from Borough counsel as were the changes to the Employment Agreement. He recommended that the Board re-approve the Shared Services Agreement with the changes agreed upon with Butler.
