RESOLUTION NO. R-09-5-3

RESOLUTION ESTABLISHING THE OFFICE OF PURCHASING AGENT AND APPOINTING DANIEL D. KELLY, P.E. OF KELLY ENGINEERING TO THE POSITION OF PURCHASING AGENT OF THE PEQUANNOCK RIVER BASIN REGIONAL SEWERAGE AUTHORITY

WHEREAS, the Pequannock River Basin Regional Sewerage Authority (the "PRBRSA") is a sowerage authority subject to the Sewerage Authorities Law, N.J.S.A. 40:14A-1 et seq. and

WHEREAS, pursuant to section N.J.S.A. 40:14A-7 of the Sewerage Authorities Law, sewerage authorities have the statutory power to make purchases and enter into contracts awarded by a contracting agent for the provision or performance of goods or services subject to the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq.; and

WHEREAS, the PRBRSA is a "contracting unit" under the Local Public Contracts Lawr and

WHEREAS, pursuant to section N.J.S.A. 40A:11-9 of the Local Public Contracts Law, the governing body of any contracting unit may by resolution establish the office of purchasing agent, with the authority, responsibility, and accountability as its contracting agent, for the purchasing activity for the contracting unit, to prepare public advertising for bids and to receive bids for the provision or performance of goods or services on behalf of the contracting unit and to award contracts which are not required to be advertised under the Local Public Contracts Law in the name of the contracting unit, and conduct any activities that may be necessary or appropriate to the purchasing function of the contracting unit; and

WHEREAS, the PRBRSA wishes to establish the office of purchasing agent to carry out any of the aforementioned purchasing and contracting functions of the PRBRSA which may be necessary or appropriate from time to time;

NOW, THEREFORE, BE IT RESOLVED, on this 20th day of May. 2009, by the governing body of the Pequannock River Basin Regional Sewerage Authority, in the Counties of Merris and Passaic in the State of New Jersey, as follows:

- 1. The Pequannock River Basin Regional Sewerage Authority hereby establishes the office of purchasing agent of the Pequannock River Basin Regional Sewerage Authority.
- 2. The Pequannock River Basin Regional Sewerage Authority ("PRBRSA") hereby appoints Daniel D. Kelly, P.E. to serve as the purchasing agent of the PRERSA pursuant to N.J.S.A. 40A:11-9.
- 3. This Resolution shall take effect immediately.
